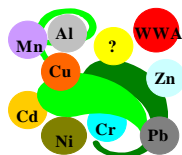

FIRST ANNOUNCEMENT

Department of Agricultural and Environmental Chemistry of the Hugo Kołłątaj University of Agriculture in Krakow and the Krakow Branch of Polish Society of Ecological Engineering would like to kindly invite you to participate in the VII International Scientific Conference on:

TOXIC SUBSTANCES IN ENVIRONMENT Krakow, 25-26 June, 2013.

Including:

- sources and transformations of toxic substances (trace elements, nitrogen compounds, organic compounds) in individual components of environment (air, water, soil),
- effect of toxic substances in live organisms (quantity and quality of plant yields, toxic substances accumulation in farm and wild animals organisms),
- effect of toxic substances on enzymatic activity of soil,
- comparison of quality of organic and conventional farms products,
- methods of harmful substances immobilization and neutralisation in environment,
- methods of cleaning of water and ground contaminated with chemical substances,
- ecological determinants of agricultural utilisation of waste materials (inter alia sewage sludge, bottom sediments) as alternative sources of fertilizer substances,
- reclamation of degraded grounds and their utilisation in biomass production for energy purposes,
- directions of degraded areas revitalization.

You are invited to submit titles and abstracts of papers **by 15 February 2013**. Abstracts (1 page, with electronic version) should include: title, author(s) name(s), affiliation, e-mail of corresponding author, objective of the study, methods, results (also in the form of a table or figure) and conclusions.

Second Announcement (by **31 March, 2013**) will contain information about the form of presentation and instructions concerning preparation of manuscripts for publication. Papers after positive review will be published in journals *Ecological Chemistry and Engineering A*, *Acta Scientiarum Polonorum Formatio Circumiectus* and *Inżynieria Ekologiczna*.

Registration fee c.a. 300 EU includes: organisational costs, full board, publish of one submitted paper (8 pages including summary and list of references). Longer papers may be published at additional cost c.a. 25 EU per one page.

Conference beginning will take place 25 June, 2013 at 9:30 a.m. and completion is planned June 26, 2013 at 3:00 p.m.
